#### **Action Items**

1. Approval of the Agenda

Jim Moody moved to approve the agenda, seconded by Lisa Walker. The motion passed.

2. Conversation with CareerSource Florida about realignment and next steps

Diane Head, ED introduced Adrienne Johnston, CareerSource Florida's, President, CEO to the Consortium. President Johnston provided a status update and briefly discussed Ernst & Young's Future State Options Report which was prepared for CareerSource Florida as a part of Phase Two of the Local Workforce Development Board Alignment Evaluation. This phase includes regional planning and the development of a franchise model. The Consortium was informed of a few upcoming webinar sessions for Directors and Local Elected Officials, dates to be determined.



#### 3. Conversation about regional planning areas

The Workforce Innovation and Opportunity Act (WIOA) strongly encourages states to create planning regions that combine two or more local workforce development bords and areas to align workforce development activities and resources with larger regional economic development areas and available resources to provide coordinated and efficient services to both job seekers and employers. The updated planning regions among the newly structured 21 local workforce development boards also allows the CareerSource Florida network to continue seeking system-wide access, alignment, and accountability improvements expected by the REACH Act.

The Commissioners agreed to meet quarterly (4 times a year) for the restructuring discussions and outcomes. Commissioner Lisa Walker suggested late afternoon meetings, preferably the first Thursday of each quarter, upcoming meeting date TBD.

#### 2. Performance

Diane Head informed the consortium of CSNF's first year (PY 2022-2023) receiving a letter grade of 'A'. CSNF ranks second in the State. Q4 not yet complete. New grades will be published on 10/15/23.

#### 3. Bylaws Update

Diane Head informed the Consortium of the Bylaws revision on May 18,2023 which includes language of term limits for Board members.
